

ASSIGNMENT OF PROCEEDS

In consideration of the purchase of the school property and building of School District No. 2 of the Town of Wright, Schoharie County, New York, by the Gallupville Fire and Hose Company, we, the undersigned owners and possessors of taxable property in the above school district, hereby give and assign to the Gallupville Fire and Hose Company upon its incorporation as a membership corporation in the State of New York, all our right, title, and interest in the proceeds of sale of the said school property and buildings to the Gallupville Fire and Hose Company, of the Town of Wright, Schoharie County, New York, after our receipt of said proceeds.

This assignment is made on the express condition that the said school property and building shall be used by the Gallupville Fire and Hose Company, incorporated, for the preservation, protection, and storing of fire apparatus and equipment and for the social, and recreational use of the members of said corporation and the residents of the said district, and that when said property and building cease to be used for the above purposes by the Gallupville Fire and Hose Company, incorporated, our respective interests hereby assigned shall revert to the said School District No. 2 of the Town of Wright, Schoharie County, New York, to be distributed among ourselves, our heirs, successors, and assigns, whom we bind by these presents, as our interest shall appear.
